**POLL RESULTS OF THE 2016 ANNUAL GENERAL MEETING
HELD ON 27 JUNE 2017**

The Board is pleased to announce that all the resolutions set out in the AGM Notice were duly passed by the Shareholders at the AGM held on 27 June 2017 by way of poll.

Reference is made to the notice of the AGM dated 31 March 2017 (the “**AGM Notice**”) and the circular of the Company dated 31 March 2017 (the “**Circular**”). Unless otherwise stated, capitalized items used herein shall have the same meanings as those defined in the AGM Notice and the Circular.

The Board is pleased to announce that all the resolutions set out in the AGM Notice were duly passed by the Shareholders at the AGM held on 27 June 2017 by way of poll.

As at the date of the AGM, the total number of promoters Shares and H Shares were 700,000,000 Shares and 678,720,000 Shares respectively, which were the total number of Shares entitling the holders to attend and vote on the resolutions at the AGM. There was no Share entitling any Shareholder to attend and abstain from voting in favour of resolutions at the AGM as set out in rule 17.47A of the GEM Listing Rules and no Shareholders were required under the GEM Listing Rules to abstain from voting at the AGM. No Shareholder has stated in the Circular that he/she/it intended to vote against or to abstain from voting on the resolutions at the AGM.

The Company appointed Hong Kong Registrars Limited, being the Company's H share registrar in Hong Kong, and Beijing Grandway Law Offices to scrutinise the voting at the AGM. The poll results in respect of the resolutions at the AGM are as follows:
